


Some of the challenges we face



In the Royal Borough of Windsor and Maidenhead – these are not unique


In the Royal Borough in 2017, our CO2 emissions were 850kt, with transport being 49% of those emissions



- 147,000 residents, with 10% growth in the next 10 years
- Lowest council tax outside London by a considerable amount
- No budget for reducing emissions, tackling climate change

To reach carbon zero by 2050 there needs to be a minimum reduction of 13.1% per annum

- The next two years are critical, with every week accounting for 1% of available time
- All hands on deck 1. Government, RBWM, academia, 2. Individuals and community groups, and 3. businesses, farmers and landowners



"I used to think the top environmental problems were biodiversity loss, ecosystem collapse, and climate change. I thought that with 30 years of good science we could address those problems. But I was wrong. The top environmental problems are selfishness, greed and apathy.... ... and to deal with those we need a spiritual and cultural transformation, and we scientists don't the that" US environmental lawyer

Throughout my working life I have relied on Fair Process when working with groups

- When people do not trust others to make good decisions, or behave with integrity, their motivation is seriously compromised
- They might hold onto their knowledge rather than share it –
 "knowledge is power", even if it is to their detriment in the longer run
- This is particularly pertinent in a knowledge based organisation like ours, where innovation and the sharing of knowledge is key

The central premise of fair process is that people will commit to a decision, even one they disagree with, if they believe that the process that was used to make the decision was fair

There are three steps to achieving a good outcome with Fair Process

- Engagement ask for input and allow individuals to refute the merits of one another's ideas and assumptions
- <u>Explanation</u> everyone involved and affected should understand why final decisions are made as they are
- Expectations Clarity once a decision is made, officers/members/stakeholders state clearly the new rules of the games, new targets and milestones

Fair process is not 'decision by consensus'

- Fair process does not seek to achieve harmony or to win people's support through compromise that accommodate every individuals opinions, needs and interests
- Fair process pursues the best ideas, whether they are put forward by one or many
- You need to start the process of involvement asap don't wait until residents or stakeholders seek retributive justice



Since declaring an environmental and climate emergency we have...

- Appointed two cross party vice chairmen
- Switched all our council electricity to clean
- Held stakeholder workshops with over eighty providing input to the strategy
- Secured two citizens assemblies driven by university professors
- Worked with our parks contractors to increase biodiversity on verges and in parks
- Found external experts in Communications, measurement, energy and biodiversity to help us deliver our strategy
- Starting to develop a strategy that looks at reducing CO2 whilst increasing resident wellbeing and demonstrably improving the wider environment.
